#### Purpose of data processing:

Your personal data is collected and processed exclusively for the purpose of processing your application and for contacting you as part of the application process for the Prep Course Public Management, the awarding of a scholarship and further organisational processing for the Prep Course Public Management.

#### Legal basis for processing personal data:

The processing of your data is necessary to fulfil the tasks of the university in accordance with Art. 6 para. 1 sentence 1 lit. e GDPR in conjunction with Section 12 of the State Higher Education Act in conjunction with the data protection statutes of University of Applied Sciences Kehl. As far as voluntary information is concerned, the information is based on your consent, Art. 6 para. 1 sentence 1 lit. a, 9 para. 2 lit. a GDPR.

#### Type of data collected:

We collect and process the following personal data that you provide to us as part of your application: Names, date and place of birth, correspondence address, e-mail address, school and university qualifications with officially certified copies of certificates, language certificates, professional experience and any study or professional stays abroad you have already completed. In order to better meet your needs, you can provide us with the following information on a voluntary basis: Disabilities and health restrictions. To be able to contact you in case of any questions, you may provide us your telephone number.

#### Recipients of personal data:

Your personal data will only be transferred to internal departments, to the DAAD as scholarship provider (if applicable) and, if you are interested in a room in a student residence, to the respective operator.

## **Duration of storage:**

Your data will be stored until the application process has been completed. If we are unable to offer you a place in the Prep Course Public Management, your data will be stored for up to six months after the end of the application process. The retention serves in particular to provide evidence in the event of a legal dispute. If it is evident that the data will be required after the 6-month period has expired (e.g. due to an impending or pending legal dispute), it will only be deleted when the purpose for further storage no longer applies. Longer storage may also take place if you have given your consent (Art. 6 para. 1 lit. a GDPR) or if statutory retention obligations prevent deletion.







## Rights of data subjects:

According to Art. 15 of the EU General Data Protection Regulation (EU GDPR), data subjects are entitled to free information as to whether personal data relating to them is being processed and, if so, which personal data is involved. In principle, a copy of the data can be requested, unless a legal exception applies. If the data is incomplete or incorrect, there is a right to rectification in accordance with Art. 16 GDPR. Further data subject rights are:

- Art. 17 EU GDPR: Erasure of own personal data if there is a reason for erasure stated therein.
- Art. 18 EU GDPR: Restriction of the processing of personal data if there is a reason stated therein.
- Art. 20 EU GDPR: Transfer of own personal data to a provider if the processing is based on consent or on a contract.
- Art. 21 EU GDPR: There may be a right to object to otherwise lawful processing of personal data on grounds relating to a particular personal situation.
- Art. 22 EU GDPR: Grants special data subject rights in the case of automated decisions in individual cases, including profiling.

#### Revocation of consent:

You can withdraw your consent to the processing of your personal data at any time. The revocation applies from the time of the declaration and does not affect the legality of the processing carried out up to that point.

### Right to lodge a complaint:

You have a right of access (Art. 15 GDPR) and a right to rectification (Art. 16 GDPR) or erasure (Art. 17 GDPR) or to restriction of processing (Art. 18 GDPR) or a right to object to processing (Art. 21 GDPR) and a right to data portability (Art. 20 GDPR).
